



7 tips before buying a tax cash register



1.

What exactly is a tax cash register and do I need it?

The tax cash register is a cash register that enables the exchange of data with the FURS server in real time. In the Republic of Slovenia, tax cash registers are mandatory from January 1, 2016.

A cash register is software that can be installed on your pre-existing devices (tablets, phones, or computers) so you don't have a high cost of purchasing it. If you will or if you are doing business with cash, we recommend buying a tax cash register, as it saves you a lot of time and brings quite a few unexpected benefits.

Do I need the internet?



to use tax cash registers, you need an internet connection to validate invoices via the FURS server in real-time. You can use a fixed internet connection or a mobile internet connection (SIM card).

How much does the tax cash register cost?

In case you already have a **tablet, smartphone or computer**, the monthly rent of the tax cash register will cost you **a little more than 10 €**. The initial installation costs range from **30 € to 100 €**.

What do I need to introduce a tax cash register?

Before introducing a tax cash register, it is necessary to prepare:

You can enter all data into the tax cash register yourself.

- price list of items,
- list of cashiers with their tax numbers,
- internal act,
- the dedicated digital certificate for tax certification of invoices.

What is an internal act?

Before you start tax certification of invoices, you must adopt an internal act. An internal act is a form in which you list business premises. Samples of internal acts can be found on the FURS website.

What is a dedicated digital certificate for tax certification of invoices and where do I get it?

It is a dedicated digital certificate for the implementation of tax certification of invoices. Obtain it via the eDavki portal, where it is necessary to submit an electronic application for obtaining a dedicated digital certificate for the implementation of the tax certification of invoices under the name DPR-PridobitevDP.

How do I obtain a dedicated digital certificate for tax cash registers?

6.1.1. On the website edavki.durs.si you choose: **Vstop za registrirane uporabnike.**

In the "Dokumenti" menu, under "Nov dokument", select the DPR-PridobitevDP request and sign it electronically. After submitting the application, you will receive a reference number and password for receiving a dedicated certificate in the personal part of the eDavki portal.

6.1.2. The received reference number and password are then entered into the portal for downloading a dedicated digital certificate, which can be found at www.tax-ca.gov.si/prevzem
